## News and Notes

This is Environmental Health Professionals week, and the start of Preparedness Month.

## Preparedness Month

'Preparedness Starts at Home' is the theme for this year's National Preparedness Month. Each September, efforts to promote preparedness amongst communities, individuals and families are conducted nationwide. When disasters wipe out electrical power, transportation routes, and other daily necessities, it is helpful to have a three-day supply of non-perishable foods, water, medicines, and other staples on hand. Communication plans, batteries, and items specifically for family members of all ages and pets are also invaluable.

Promotions for preparedness efforts have been conducted throughout the state including Health Districts in Dalton, Clayton, Fulton, Gainesville, and others. In the Coastal Health District, preparedness includes maintaining the Hurricane Registry, a tool to assist those who may need help during hurricane evacuations. 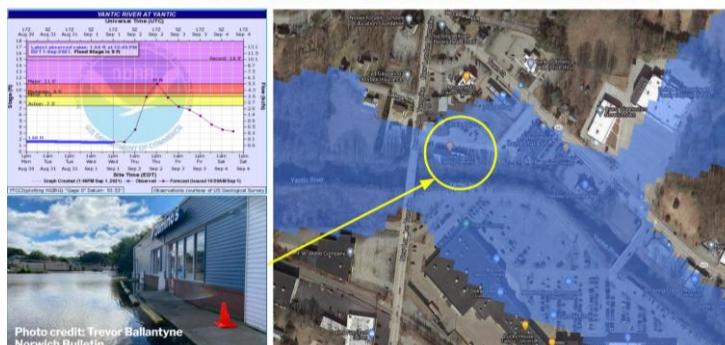


Health District Half-Time: The Hurricane Registry

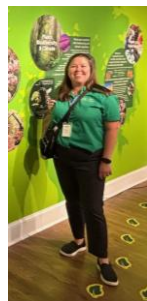

Monday is 988 Day in Georgia. The suicide and crisis lifeline is expanding and having a positive impact. *"We know 988 can save lives," said Georgia Department of Behavioral Health and Developmental Disabilities Commissioner Kevin Tanner. "But awareness and trust are everything."* In the past two months, 393 individuals registered and completed 988 training. Additionally, 204 organizations across the state were represented to ensure workplaces, service providers and community groups were better connected.

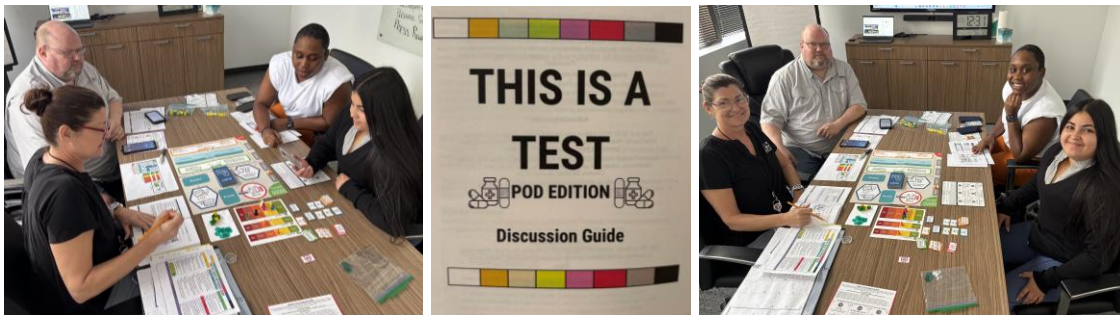


## Risk Communicator quarterly meeting
